Open to all customs, rods, muscle cars, trucks, and motorcycles. Entries are limited and subject to the discretion of Cruisin' for Down Syndrome or the NDSCoalition staff. All vehicles must be registered and carry proof of automobile liability insurance with minimum of \$15,000/\$30,000 bodily injury \$10,000 property damage. Proof of insurance must be shown at check-in for the car registered. All registered vehicles must have current DMV registration. All registered vehicles will be issued a window plaque with identification number for that vehicle. Vehicles must display window plaque on the passenger's side of the windshield at all times. Switching of window stickers from one vehicle to another or coping the sticker and placing in another car is prohibited and will result in eviction from the event. The directors and event management of Cruisin' for Down Syndrome reserves the right to restrict entrants to acceptable behavior during any and all activities. For any reason an entrant or his/her vehicle, their appearance or conducts are deemed objectionable by the directors or management, entrant and his/her vehicle will be evicted from the event. This includes, persons, things, conduct, printed material or any act or item of poor character considered objectionable. No refunds will be returned in the case of an eviction. There will be no bicycles, scooters, roller blades or skateboards allowed in during the Cruisin' for Down Syndrome event. In consideration of acceptance of participants to the show Cruisin' for Down Syndrome on May 14, 2011 by execution of this entry form, I hereby release the National Down Syndrome Coalition, "Cruisin' for Down Syndrome" and their members, officers, employees, or anyone else connected with this event from any known or unknown damages, injuries, losses, judgments, and/or claims from any causes whatsoever that may be suffered by anyone participating in this event, or by any spectators.
